Pr. q̄ charos habeat Lutherus Pighardos, quos tot⁹ orbis (vt ip̄emet ait) pestilētissimos vocat haereticos, licet ab illis nullis laudib⁹ aut blanditijs impetrare potuerit, vt doctrinā aut sectā eius approbent aut recipiant, Qd̄ & a Senatu Pragenſi nullis vel scripturis & suasionibus vel adulationibus laudūq; blādimētis exorare aut cōsequi potuit, licet Christianissim⁹ Princeps, FERDINANDVS, eo tēpore nōdū esset Bohemis a Deo Rex dat⁹, Tātū abest, vt nūc sub hoc Rege (q̄ Luthericā & p̄fidā & impuritātē maxie deſtat & odit) quicquā a Bohemis sperare possit.
