DECRETUM.

Sacra Congregatio Religiosorum Negotiis praeposita, relatione Visitatorum Apostolicorum utriusque Congregationis Austriacae O. S. B. sedulo perpensa et discussa, quo incepturn opus ad optatum finem salubriter deducatur, sequentia, praesentis Decreti tenore servanda decernit:

1. Omnia monasteria benedictina utriusque Congregationis Austriacae subjiciuntur ad nutum S. Sedis regimini extraordinario Visitatorum Apostolicorum Abb. Zeller et Landersdorfer, quos haec Sacra Congregatio constituit Administratores Apostolicos, Praesides vero utriusque Congregationis munere suo cessant, dum caeteri Abbates integrum potestatem regendi proprium monasterium retinent.

2. Unde haec Sacra Congregatio eisdem Administratoribus Apostolicis plenam tribuit potestatem, qua Praesides praedictarum Congregationum juxta sacros Canones et statuta particularia gaudent. Insuper eis facultatem et jurisdictionem concedit providendi omnia, quae ad bonum sive temporale, sive spirituale monasteriorum illorum pertinent; imprimis ea, quae ad instaurandam disciplinam monasticam iuxta mentem S. Sedis spectant.

3. Administratores Apostolici igitur convocent quam primum omnes Abbates utriusque Congregationis necnon Abbatem Seccoviensem Congregationis Beuronensis, eisque deliberandum proponant:

a) quae fieri oporteat ut Decretum S. Congregationis diei 22 junii 1924 accuratius servetur, imprimis qua ratione ipsi Abbates vitam suam iuxta nor-
