Sbigne⁹ hui⁹ vrbi p̄fuit ep̄s līaz doctrina ⁊ morum suauitate insignis, a quo plurimas accepim⁹ ep̄las multo sale ⁊ romana elegātia p̄ditas, cui ob singulares virtutes romana ecclia insignē cardinalat⁹ honoris rubentē pileū misit.
